Thank you for your interest in the Local Impact Investor Accelerator for Indiana community foundations. We have provided initial information below to help with your planning and decision making. The Accelerator is made possible through a partnership of LOCUS Impact Investing (LOCUS) and the Indiana Philanthropy Alliance (IPA). This program builds upon IPA's commitment to strengthen and grow Indiana philanthropy and LOCUS' mission to help foundations explore the tool of local impact investing in support of more prosperous and equitable communities.

Contracting

The LOCUS Local Impact Investing Accelerator strategy is an investment in the foundation – and your community – that requires financial resources, time, and commitment on the part of foundation staff and board members. Our work together will set a new strategic direction for the foundation and provide the structure and tools to successfully act on that strategy. The cost for this engagement is \$26,500 per foundation and will be confirmed through a contract between LOCUS Impact Investing and you. You may provide payment to LOCUS in a method and timeline that works best for you. Some foundations have covered the cost by using grant funds to support their own organizational development and expanded community leadership. As a nonprofit, LOCUS is familiar with grant and reporting requirements.

Building your Working Group

The crux of Accelerator experience is your foundation team. Each team should include participants who are critical – as decisionmakers, influencers and/or implementers – to strengthening your foundation's community leadership using the tool of local investing. We recommend a Working Group of no fewer than 3 and no more than 7 members. Your team should include key foundation staff (e.g., CEO, CFO, Program Officer), board members (e.g., Board Chair, members of investment committee) and/or engaged community partners (e.g. community members of your investment or grants committee). As you finalize your Working Group, consider whether each team member – and the team as a whole – meet these criteria:

- Has the capacity, by position or personal characteristics, to influence your community foundation's understanding, vision, action, and practices now and in the foreseeable future.
- Brings key decision-making, implementation and/or advocacy skills to your work during the Accelerator, and as you carry the work on in the future.
- Represents a key component of the diversity in your community.
- Agrees to attend all Accelerator workshops and meetings (Accelerator will require approximately 45-55 volunteer hours for your Working Group members)

Next Steps

Our first activity together is the Virtual Site visit, the objective of which is to ensure that the LOCUS team gains a good understanding of your unique starting point. This is also an opportunity for the members of your Working Group to get to know LOCUS and how we will work together. Upon execution of the contract, LOCUS will provide a site visit overview and work with you to identify a date.
